「父母管教與香港青少年的發展結果」研究

本校現正與香港理工大學應用社會科學系合作進行一項為期三年的「追蹤性」研究——「父母管教與香港青少年的發展結果」研究。是項研究由香港理工大學應用社會科學系助理教授朱小琴博士負責，旨在了解父母對子女的不同管教方式對香港青少年的發展結果的影響及作用機制。此項研究的結果，對了解香港父母的管教方式，及有效地制訂有關的家庭支持服務以提升父母管教的有效性及青少年的正面發展有極大的幫助。

Study on Parenting and Developmental Outcomes of Adolescents in Hong Kong

We are currently conducting a three-year longitudinal research study titled “*Parenting and Developmental Outcomes of Adolescents in Hong Kong*” in collaboration with the Department of Applied Social Sciences at The Hong Kong Polytechnic University (PolyU). This study is led by Dr. Xiaoqin ZHU, an Assistant Professor at PolyU. The study aims to understand the impact of different parenting practices on the developmental outcomes of adolescents in Hong Kong and the underlying mechanisms. The findings from this research will help us better understand the profiles of parenting practices in Hong Kong and contribute to the development of family services to promote effective parenting and high-quality parent-child relationships, which ultimately nurture adolescents’ optimal development.

Details of the study are as follows:

1. During 2024-2026, the research team will come to school each year and instruct all participating students to complete the same questionnaire.
2. As a token of appreciation, the research team will provide your child with a supermarket voucher worth HK\$50 upon completion of the questionnaire each year.
3. All information provided by your child will be kept confidential strictly. Individual participants’ identities and data will never be disclosed. All questionnaires will be destroyed within three years after the completion of this project.
4. Participants can withdraw from the study at any time without penalty of any kind.

This research has been approved by the Institutional Review Board (Reference Number: HSEARS20221013006) at PolyU.
